No family or friends will be allowed in the studio to watch tryouts. Notification of results will be submitted to all athletes via email to the email address noted on the try-out packet.

**Results will be emailed on Sunday June 9th at 10:00am. Cheerleaders who make the team, and their parents, are required to attend a mandatory meeting on Sunday June 9th at Spreckels Park at 4:30pm.**

## **2024-2025 Cheer Team Participation**

### **Cheerleader Expectations:**

The most important requirements are a positive attitude, team player, hard worker, commitment, and the ability to follow instructions and rules. Cheerleaders must demonstrate the highest standards of honesty and reliability; always showing respect, concern, and care for others. In addition, they must be punctual and dependable.

### **Expectations – Conduct – Discipline:**

- Sportsmanship is our top priority. You will be expected to respect all members of this team, other teams, your Coach, and other coaches at ALL times.
- It is our goal that involvement with this program will develop each athlete's character, and skill level all while instilling a great work ethic and teaching responsibility.
- You will be expected to represent Coronado Cheer and this community to the very best of your ability. You will not be permitted to use profanity or display any obscene gestures at practice, performances, on social media, or any team functions at any time.
- Any form of harassment or "hazing" behaviors will result in immediate Expulsion from the team.



- You will be required to work closely with your teammates and appreciate their talents and strengths. You will be expected to help one another and build team unity. Gossip and destructive behavior will not be tolerated.

### **Practices:**

- Practices will be held 2-3 times per week and will usually run about 2 hours.
- Extra practices will be held on Saturdays at Legacy Gymnastics Academy and can run 2-4 hours. Saturday practices are listed in the team schedule.
- As important events arise, additional practices may be added accordingly, however advanced notice will be provided for planning purposes.
- All athletes are expected to show up to every practice fully prepared with ALL gear. ALL gear, this includes proper shoes, hair pulled back and athletic clothing for the appropriate practice.
- Jewelry is NOT allowed to be worn at practices.
- No eating or chewing gum at practices and performances.
- Fingernails must be kept at an appropriate length for safe participation. Artificial nails and nail polish of any kind is prohibited.
- The use of cell phones will NOT be allowed during practice.
- ALL practices are mandatory and tardiness is unacceptable. \*\*\*Please schedule all non-emergency appointments around our scheduled practice times. If there are extenuating circumstances, the coach(s) will need to be notified by a parent or guardian to determine if your absence will be excused. Excessive absences will result in suspension from performances and potentially the team.
- Illness: You must be fever free for 24 hours (without fever reducer) to attend any cheer event.

### **Transportation:**

- Parents are responsible for transporting his or her cheerleader to and from events.

### **Communication:**

- All teams will use the Band App to communicate practice schedules, performance schedules, videos for review, and other important information throughout the season. Be respectful of your coach's free time. All



communication should go through the Band App. Read all comments and announcements before asking a question. Coaches have 24 hours to respond to any questions or comments.

### **Examples of Excused Absences:**

- Family emergencies
- Illnesses
- Pre-arranged trips or events that have been excused by the Coach

### **Examples of Unexcused Absences:**

- Regular doctor's appointments (i.e. check-ups, dentist appointments, immunization shots). These types of non-emergency appointments should be made on non-practice days and will be Unexcused.

On behalf of my child, to the fullest extent permissible by applicable law, I hereby release and hold harmless Coronado Cheer, its advisors, its coaches, its agents, and its employees from any and all liability for any accident, injury, or damages that might occur or arise during practice, during any event, during travel to or from any event, or as a result of my child's participation on the Cheer Team. Each participant must obtain his or her own medical or health insurance and provide proof of such medical or health insurance.

My child assumes all risks of injury and damages that may arise as a result of his or her participation on the Cheer Team, which I, and my child recognize is a competitive and physically demanding sport.



Participants can reduce the chance of injury by obeying all safety rules, immediately reporting all physical problems to their coach and advisor, and following a proper conditioning program. Even if all of these requirements are met, I understand the possibility that an injury may still occur.

### **Coronado Cheer Competition Team Cost:**

Monthly Tuition: \$160 per month for 6 months. August 1st - January 31st.

Uniform: \$250 Uniform payment is due on July 1st.

Shoes will be purchased individually, however, must be an approved shoe by the coach. Shoes for the season must be all white and must be an approved cheer shoe.

### **Costs included in your monthly tuition:**

- Competition entry fees
- Practice gear (Shirt and Bow)
- Facility rental (CHS quad, Legacy Gymnastics Academy, CHS gym)
- Music license fees
- Insurance
- Coach fees
- Choreography
- Safety equipment

Monthly tuition payments will be made on the first of every month by autopay. Uniform payment is due on July 1st.

### **What your child needs for cheer:**

- black athletic shorts for practices
- white cheer shoes
- white ankle socks

If a cheerleader quits or is released from the squad for any reason, after the contract has been signed, they will be financially responsible for all items ordered as well as monthly tuition for the following 30 days. **No refunds will be given.** If a cheerleader loses any part of the uniform, they will be responsible to re-purchase the item.

We will plan several fundraising opportunities throughout the season. Participation from all cheerleaders and families is extremely important. Fundraising monies will be used





for costs such as ready rooms at competitions, end of season parties, items for theme practices, team parties and other events throughout the season.

Upon acceptance of a position on the team, you will sign a contract agreeing to financial and time commitments. Do not try out “just to see” if you will make it. If you cannot commit to the team schedule, you should not try out.
